## 1. Calculating the number of users

GnuPG Desktop<sup>®</sup> is distributed within the framework of a software support and maintenance contract. The number of required support licenses is determined by the following rules:

One license is required for

a) each person using the software. The software can be installed and used by this person on any number of devices.

b) each dedicated computer on which the software is used by several persons within the same keys.

For automated processing of data 5 licenses are required for the first computer used and 3 licenses for each additional computer. The term "computer" is used here to refer to one instance of an operating system.

## 2. Subsequent purchase of licenses

It is possible to add further users during the term of the contract. The number of users added in the course of a contract year must be reported accordingly and will be invoiced annually in arrears. For each month or part thereof, 1/12 of the annual price is charged. For the calculation in arrears, the price for the 1st year is used as a basis. The discounted price "from the 2nd year" is then calculated pro rata for the following year.

The Standard-package is automatically upgraded to the services of the Enterprise-package as soon as the number of purchased licenses exceeds 249.

## 3. Discount for Linux version

Provided that GnuPG Desktop<sup>®</sup> is used exclusively on Linux systems, we grant a discount of 30 percent on the price of the first and subsequent years.

## 4. Term and conditions of payment

Unless otherwise agreed, the term of the support and maintenance contract shall be one year and shall be extended by a further year unless notice of termination is given in writing 4 weeks before the end of the term. Contracts with a term of more than one year are not automatically renewed.

The price is payable annually in advance. And payable within 30 days after invoicing without deduction. From the 2nd year on, the current price "from 2nd year" will be charged for already existing contracts.

## 5. Miscellaneous

All prices are subject to the applicable statutory value added tax. The contract is subject to German law to the exclusion of the UN Convention on Contracts for the International Sale of Goods. The place of jurisdiction shall be the competent court at the registered office of g10 Code GmbH.
